	If <b>We</b> establish that <b>You</b> deliberately or recklessly provided <b>Us</b> with false or misleading information <b>We</b> will treat <b>Your</b> Policy as if it never existed and decline all claims. <b>We</b> may not return premium already paid by <b>You</b> in this situation.

#### LEGISLATION

In this Policy **We** make reference to various laws and statutes. There follows a brief description of each. This is intended for information purposes only and is not part of **Your** Policy terms.

The laws and statutes referred to below shall apply as amended or replaced from time to time.

Consumer Protection Act 1987	Designed to protect consumers from products that do not reach a reasonable level of safety.
Contracts (Rights of Third Parties) Act 1999	Makes provision for the enforcement of contractual terms by third parties.
Corporate Manslaughter and Corporate Homicide Act 2007	States that companies and organisations can be found guilty of corporate manslaughter or homicide if serious management failures cause a person's death and amount to a breach of a duty of care.
Defective Premises Act 1972	Imposes duties in connection with the provision of premises and imposes liability for injury or damage caused to persons through defects in the state of the premises. In certain circumstances the duty of care is extended to after the premises have been disposed of.
Defective Premises (Northern Ireland) Order 1975	Imposes duties in connection with the provision of premises and imposes liability for injury or damage caused to persons through defects in the state of the premises. In certain circumstances the duty of care is extended to after the premises have been disposed of.
EU Environmental Liability Directive	Establishes a framework based on the "polluter pays" principle to prevent and remedy environmental damage.
Food Safety Act 1990	Provides the framework for all food legislation in Britain and sets out the duties of food producers and food handlers in relation to food safety.
GDPR	Controls how an individual's personal data is used by organisations, businesses or the government.
Health and Safety at Work etc Act 1974	Places duties on all employers to ensure, so far as reasonably practicable, the health, safety and welfare at work of all employees.
Health and Safety at Work (Northern Ireland) Order	Places duties on all employers to ensure, so far as is reasonably practicable, the health, safety and welfare at work of all employees.

Road Traffic Act 1988	Consolidates certain enactments relating to road traffic, including road safety, construction and use of vehicles and equipment, licensing of drivers of vehicles, driving instruction and third-party liabilities.
Road Traffic Northern Ireland Order 1981	Relates to road traffic, including road safety, licensing of drivers of vehicles, regulation of motor vehicles, foreign vehicles and insurance against third-party liabilities.

These apply to all Sections of this Policy and all Endorsements and Extensions unless otherwise stated.

Claims conditions	(1).	<ul> <li>(a) It is a condition precedent that You give notice in writing without delay of anything which may give rise to any claim being made against You and for which there may be liability under this Policy. If You do not do so We may reject or be unable to deal with Your claim or be unable to pay Your claim in full. Details of how to give this notice are given on page 4.</li> <li>(b) It is a condition precedent that You give notice in writing without delay when any claim is actually made against You (whether written or oral) and for which there may be liability under this Policy. If You do not do so We may reject or be unable to deal with Your claim or be unable to pay Your claim in full. Details of how to report a claim are given on page 4.</li> <li>(c) It is a condition precedent that You advise Us in writing without delay if at any time You know of any impending prosecution, inquest or fatal accident inquiry in connection with any claim or circumstance notified under (a) or (b) above. If You do not do so We may reject or be unable to pay Your claim in full. Claims Control		We shall be entitled to take over and conduct in <b>Your</b> name the defence or settlement of any claim, and may prosecute at <b>Our</b> own expense and for <b>Our</b> benefit any claim for insurance or damages against any other persons, and <b>You</b> shall give all information and assistance required. If <b>You</b> do not do so <b>We</b> may reject or be unable to deal with <b>Your</b> claim or be unable to pay <b>Your</b> claim in full. No admission of liability or offer, promise or payment shall be made without <b>Our</b> written consent.
Maximum sums payable	(3).	We may at any time at <b>Our</b> sole discretion pay to <b>You</b> the maximum sum payable under this Policy or any lesser sums for which any claim or claims can be settled. If <b>We</b> do this, <b>We</b> shall not be under any further liability except for the payment of costs and expenses of litigation incurred prior to such payment, provided that in the event of a claim such costs and expenses shall not exceed an amount being in the same proportion as <b>Our</b> payment to <b>You</b> bears to the total payment made by <b>You</b> or on <b>Your</b> behalf in settlement of the claim or claims.
Care and prevention	(4).	It is a condition precedent that <b>You</b> shall take all care to prevent accidents and to maintain and keep in proper repair <b>Your</b> premises, plant and everything used in the <b>Business</b> . <b>You</b> shall make good or remedy any defect or danger which becomes apparent, and take such additional precautions as the circumstances may require. <b>You</b> must also take all care to act in accordance with all statutory obligations and regulations including <b>Data Protection Legislation</b> and applicable related guidance from the Information Commissioner's Office and to employ only competent <b>Employees</b> . If <b>You</b> do not do so <b>We</b> may reject or be unable to deal with <b>Your</b> claim or be unable to pay <b>Your</b> claim in full.



Cancellation by us	(5.)	<b>We</b> can cancel this Policy by giving <b>You</b> fourteen (14) days' notice in writing. <b>We</b> will only do this for a valid reason (examples of valid reasons are as follows):
		(a) non-payment of premium;
		(b) a change in risk occurring which means that We can no longer provide You with insurance cover;
		<ul> <li>(c) non-cooperation or failure to supply any information or documentation</li> <li>We request; or</li> </ul>
		(d) threatening or abusive behaviour or the use of threatening or abusive language towards <b>Us</b> or any of <b>Our</b> appointed agents
		If this Policy is cancelled <b>You</b> will be entitled to a refund of any premium paid, subject to a deduction for any time for which <b>You</b> have been covered and a deduction for any commission paid to <b>Your</b> insurance broker. This will be calculated on a proportional basis. For example, if <b>You</b> have been covered for six (6) months, the deduction for the time <b>You</b> have been covered will be half the annual premium, in addition to the deduction for any commission paid to <b>Your</b> insurance broker. If <b>You</b> have made a claim, or one has been made against <b>You</b> or an incident has occurred which may result in a claim, <b>You</b> must pay the full annual premium and <b>You</b> will not be entitled to any refund.
Cancellation by You	(6.)	<b>You</b> can cancel this policy which can take effect immediately or from a later date, although it cannot be backdated to an earlier date. <b>You</b> will be entitled to a refund of any premium paid, subject to a deduction for any time for which <b>You</b> have been covered and a deduction for any commission paid to <b>Your</b> insurance broker. This will be calculated on a proportional basis. For example, if <b>You</b> have been covered for six (6) months, the deduction for the time <b>You</b> have been covered will be half the annual premium, in addition to the deduction for any commission paid to <b>Your</b> insurance broker.
		If <b>You</b> have made a claim, or one has been made against <b>You</b> or an incident has occurred which may result in a claim, <b>You</b> must pay the full annual premium and <b>You</b> will not be entitled to any refund.
Other insurance	(7.)	If at the time of any claim there is, or but for the existence of this Policy would be, any other insurance in favour of or purchased by <b>You</b> or on <b>Your</b> behalf, applicable to such claim, <b>We</b> shall not be liable under this Policy to pay <b>You</b> in respect of such claim except beyond the amount which would be payable under such other insurance had this Policy not been purchased.
Risk Improvement Requirements	(8.)	It is a condition precedent that <b>You</b> shall comply and continue to comply with all risk improvement requirements that have been notified to <b>You</b> and agreed to by or on <b>Your</b> behalf. If <b>You</b> do not do so <b>We</b> may reject or be unable to deal with <b>Your</b> claim or be unable to pay <b>Your</b> claim in full.
Changes in circumstances	(9.)	You shall, without delay, give notice in writing of any change in the information You provided Us with. If You do not do so We may reject or be unable to deal with Your claim or be unable to pay Your claim in full.
Governing Law	(10.)	The laws of England and Wales will apply to this Policy and any attached endorsements unless <b>We</b> agree otherwise with <b>You</b> in writing before issuing the Policy. Any disputes arising under this Policy shall be subject to the exclusive jurisdiction of the English Courts.

Contract (Rights of Third Parties) Act 1999	(11.)	A person who is not a party to this contract has no right under the Contract (Rights of Third Parties) Act 1999 (as may be amended or replaced from time to time) to enforce any term of this Policy but this does not affect any right or remedy of a third party which exists or is available apart from that Act.
